AKC All Breed Agility Trials August 11 & 12, 2018

Thank you for entering the Siberian Husky Club of America, Inc. Agility Trial!

The building will not be available to exhibitors on Friday; Building opens at 6:30 am. both Saturday and Sunday. The facility has asked that exhibitors do not walk their dogs near the Food Safety & Quality Building at 10103 Kitty. No flexi leads in the building. Crating space is limited so please be considerate of other exhibitors. Please place a mat under your crate.

Please check the final entry confirmation for your dog(s). If you find any errors, please notify the trial secretary via email at agilityentry@agilitytrialservices.com (preferred) or by phone at (815) 469-5525. If you do not get a response from me, I did not get your email, so please follow up with a phone call. Pre-trial move-ups must be received not later than 6:00 pm CDT on Monday, August 6, 2018. Day to day move-ups must be made by the close of Saturday's trial for the Sunday trial. Close of the trial will be considered when the ribbons have been awarded for the last class of the day.

Dogs in the Master classes will run before those in the Excellent classes and Novice B will run before Novice A for each jump height. Dogs in the Preferred program will run after dogs in the Regular program in their corresponding jump height. Entry numbers are preliminary, and subject to change contingent upon the move-up entries or withdrawals that may not have been received.

All dogs not having an AKC height card must be measured prior to competing. If a measurement is necessary, it is the exhibitor's responsibility to have their dog measured prior to running. Be sure to arrive early enough before your judging time. Any exhibitor who runs without having their dog measured will lose any qualifying score earned. Unless you already check-marked on the entry form "My Dog Needs To Be Measured", please notify the Trial Secretary that your dog needs to be measured.

Food will **not** be available on site but complimentary coffee and donuts will be provided in the morning for all exhibitors. There are several fast food restaurants near the trial site.

Exhibitors and spectators are expected to keep the grounds clean. Handlers who do not clean up after their dogs will be dismissed from the trial with no monies refunded.

From north or southbound I-294: exit at 95th Street (also Rtes 12/20) and exit east. Stay to the right and take the ramp to Harlem Avenue south. At the first light turn left onto 98th Street. Go to the stop sign and turn right onto Sayre Avenue. Turn left at the next stop sign onto Virginia Avenue. Turn right at the next stop sign and continue on Virginia Avenue. Pawsitively Heaven will be on the left side of the street, just past the fire station.
